PHILOSOPHY:

The general mandatory powers of the Poland Regional High School Committee are defined in the rules and regulations of the Town of Poland and in State of Maine statutes. The Poland Regional High School has full power and authorization to operate the local public schools in compliance with State of Maine mandates and the rules and regulations of the Town of Poland.

POLICY:

It is the policy of the Poland Regional High School to carry out the functions listed as assigned to it by the laws of the Federal and State governments and rules and regulations of the Town of Poland. The Poland Regional High School takes a broad view of its functions. It sees them as:

1. **Legislative or Policy Making:** The Poland Regional High School is responsible for the development of policy as guides for administrative action and for employing a Superintendent who shall implement its policies.
2. **Appraisal:** The Poland Regional High School is responsible for evaluating the effectiveness of its policies and their implementation.
3. **Provision of Financial Resources:** The Poland Regional High School is responsible for annually preparing and presenting to a town meeting a budget which will provide the resources – in terms of buildings, staff, materials, and equipment for the school system to carry out Poland Regional High School policies.
4. **Public Relations:** The Poland Regional High School is responsible for providing adequate information to the public concerning the schools work and for keeping staff and the school staff informed about the needs of the public with respect to schools.
5. **Educational Planning and Evaluation:** The Poland Regional High School is responsible for establishing educational goals, which will guide both the Poland Regional High School and the staff in working together toward the continued improvement of the educational program. The Poland Regional High School is also responsible for providing for the ongoing evaluation of the school program against the goals and objectives set forth by the Poland Regional High School and by the State Board of Education.

AMPLIFYING INSTRUCTIONS AND GUIDELINES:

The general powers and duties of the Poland Regional High School afforded by the State of Maine are set forth in statute – (Maine Revised Statutes Section §1001 of Title 20; and other references within Title 20).
