PHILOSOPHY:

Members of the Poland Regional High School Committee have legal authority for the conduct of the schools only when acting as a body legally in session.

The Poland Regional High School Committee shall not be bound in any way by any statement or action on the part of an individual School Committee member, including the Chairperson, except when the School Committee, through an adopted policy or by majority vote of the School Committee membership, has delegated the authority to him or her.

POLICY:

It is the policy of the Poland Regional High School that the duties and obligations of an individual Poland Regional High School member are as follows:

1. To familiarize himself/herself with the rules and regulations of the Town of Poland, State school laws, regulations of the State Department of Education and district policies.
2. To take advantage of the various training opportunities, which are offered locally and regionally for Poland Regional High School members.
3. To have a general knowledge of educational aims and objectives of the system.
4. To work harmoniously with other members and with town officials, without trying either to dominate the Poland Regional High School or neglect the member's share of the work to be done by the Poland Regional High School.
5. To vote and act in the Poland Regional High School's meetings impartially for the good of the students and the school department in general.
6. To accept the will of the majority vote in all cases and give wholehearted support to the resulting policy.
7. To represent the Poland Regional High School and the school to the public in such a way as to promote both interest and support for educational advancement and opportunity of students.
