#### Criminal History Record Checks on Educational Personnel

All employees of school systems and persons employed by others on behalf of school systems who are not certified or authorized will be required to obtain a Criminal History Record Check (CHRC) approval from the Department of Education based on fingerprints. Approval is not intended to reflect the individual's qualifications or ability to perform the job assigned. Once the Certification Office receives the criminal history record information and clears the application, your prints will be valid for 5 years.

You must have your fingerprints taken at a Maine approved fingerprint site. Fingerprints taken for other purposes and at other places (such as your local police station) will not be accepted.

To receive an approval, all of the below steps need to be completed: This is a three-step process......

- 1. Register online at **http://www.identogo.com**. If you do not register, you will not be able to have your fingerprints taken. There is a one-time \$55.00 fee for this process.
- 2. Take your confirmation number (received after registration) and a picture ID (a driver's license or Maine State ID is preferred) to the fingerprint site you chose when registering.
- After you have been fingerprinted, mail (OR email if using a card) the attached approval/renewal application to the Department of Education along with a \$15.00 non-refundable fee. Make a check payable to: Treasurer State of Maine or you may use a credit card.
- The total cost will be \$70.00 (\$55 to be fingerprinted; \$15 to the state to process the prints).
- If you have been fingerprinted and they have expired and you complete the attached application and send it to the State within 6 months of your current expiration, the cost is \$15.00.
- If your expiration exceeds the 6 months of your current expiration, you will need to be re-fingerprinted at a total cost of \$70.00 (\$55 to be printed; \$15 to the state).

If # 3 above is not completed, your fingerprinting will NOT be processed, delaying employment here at RSU 16.

Note from the State: From the fingerprint cards, state and federal criminal history record checks will be conducted. The results of the state and federal criminal history record checks will be forwarded to the Maine Department of Education to be used for the issuance or denial of approvals. This information is confidential and cannot be shared with a school system, professional organization such as the Maine Education Association or anyone else. There will be procedures in place by which an individual may access the information received by the Department of Education, but no one else may have access to this information. The Maine State Bureau of Identification will retain the fingerprints in an electronic civil file to be used for renewal purposes.

YOU MUST COMPLETE STEPS 1, 2 & 3 above in order to get your fingerprint status current.
